









Access to talent






Local talent

Attractive Tax system



Corporate Tax

- / 12,5% corporate tax rate
- / EU & OECD Compliant / Access to EU directives
- / No tax on profits from disposal of securities
- / No withholding taxes
- / No tax on capital gains under conditions
- / Notional Interest Deduction (NID) on investment in Cypric companies

Income tax

- / Income more than €100K/year
 - Exemption from personal income tax of 50% for new residents, applicable for the first 10 years of employment in Cyprus
- / Income less than €100K/year
 - Exemption from personal income tax of 20%, up to a maximum of €8.550 per annum for 5 years until 2020
- / Tax-free band of €19,500 for all Cyprus residents



 - Facilitate Access to Markets






Significant benefits ...



/ Applies to third-country entrepreneurs

/ Residence for 2 years (If successful: permanent residency)




- / Income tax relief of up to 50% of taxable income for natural persons investing in qualifying innovative SMEs
- / Dividend payments are exempt from taxation, enabling most technology entrepreneurs to minimize their overall tax burden.
- / "Advice for small business" Facility operated by EBRD for the enhancement of Consulting and Mentoring is SMEs in Cyprus
- / Improved regulatory framework Reengineered procedures for setting up a business
- / E-government services (Gateway Portal "ARIADNI", Digital Signaturé)



Startup Visa





Steps

Ol Submit Application for work

- Application for a Startup Visa to the Civil Registry and Migration Department
- Examination of application within three (3) weeks
- In case of approval, a residence permit will be issued valid for one (1) year (available for one more year).

Apply for an entry Visa

- Application to the Consular Authorities of the Republic for an Entry Visa
- Examination of application within three (3) weeks

03.

Evaluation of the application for the Establishment of a Startup

- The Competent Authority evaluates the application and the Business Plan
- Complete evaluation within
 Sweeks
- In case of positive evaluation: Notification of Initial Approval Right for entrepreneurial activity for two (2) years
